

3 YEAR LIMITED WARRANTY

Ultra Violet Light Water Purification

Congratulations! You have just purchased the best quality Ultra Violet Light Water Purification system on the market. **Please retain your sales order as proof of your purchase.**

To whom is this warranty extended?

Water Depot warrants its products to the original owner and guarantees that the products will be free from defects in materials and workmanship from the original date of purchase in the timelines described below.

How does my warranty work?

If, during the respective warranty period, a part proves, after inspection by Water Depot, to be defective, Water Depot will, at its sole option repair or replace that part at no charge, other than normal shipping, installation or service charges.

What is covered by the warranty?

Water Depot guarantees that, for a period of a 3 YEARS, the BODY will be free of defects in materials and workmanship and will perform its proper function and that, for a period of 3 YEARS, the ELECTRONICS and ALL OTHER PARTS will be free of defects in materials and workmanship and will perform their normal functions as long as it is maintained with proper pretreatment and servicing.

How do I obtain warranty service?

Should you need service, your local independent Water Depot Franchise is only a phone call away.

To obtain warranty service, notice must be given, within thirty (30) days of the discovery of the defect, to your local Water Depot Franchise.

General Provisions

The above warranties are effective provided the Ultra Violet Water Purification system is operated at water pressure not exceeding 125 psi, and at water temperatures not exceeding 120°F; provided further that the Ultra Violet Water Purification system is not subject to abuse, misuse, misapplication, incorrect installation, alteration, neglect, freezing, accident or negligence; and provided further that the Ultra Violet Water Purification system is not damaged as the result of any unusual force of nature such as, but not limited to flood, hurricane, tornado or earthquake. Water Depot, is excused if failure to perform its warranty obligations is the result of strikes, government regulation, materials shortages, or other circumstances beyond its control.
